ALABAMA COUNSELING ASSOCIATION History and Overview



The Alabama Counseling Association had its inception in 1954 as the Alabama Guidance Association, a locally organized, autonomous group. For years this group held state conventions and generally promoted professional development for counselors.

In 1964, during the Guidance Association's state convention at the Dinkler-Tutwiler Hotel in Birmingham, the question of national affiliation was discussed. With that question as impetus, then President Wilbur Tincher appointed a committee of seven to study the possibility of affiliating with the American Personnel and Guidance Association (APGA). Following discussions with and visits from American Personnel and Guidance Association representatives Willie Dugan, Kenneth Hoyt, and C. Winfield Scott, the committee proposed affiliation on February 14, 1966.

A proposed new constitution aligning the state organization with the American Personnel and Guidance Association constitution was presented at the 1966 state meeting in Montgomery. The membership approved the new constitution and endorsed the alignment. The Alabama Guidance Association then petitioned for national affiliation with APGA. Application for formal recognition was made in the Fall of 1966. Acceptance by the Senate of the American Personnel and Guidance Association was soon forthcoming. The charter for affiliation of the Alabama group was presented at the national convention of the American Personnel and Guidance Association in Dallas, Texas, in 1967.

On November 18, 1983, the General Session of the Alabama Personnel and Guidance Association voted to change its name to the Alabama Association for Counseling and Development in compliance with the national association's change to the American Association for Counseling and Development.

In the business session at its twenty-fifth Annual Conference in Huntsville in 1992, the state organization changed its name to the Alabama Counseling Association (ALCA) following the lead of the national organization once again.

ALCA has enjoyed remarkable growth and success in its long history. Today it has a membership of approximately 2200 members comprised of nine chapters, eleven divisions, and two affiliates. Each year the annual conference includes nationally known keynote speakers and a variety of professional opportunities. As the Association has grown, it has continued to add services for its members.

ALL 2020 Conference Attendees will be issued a tracking record of the sessions attended with the certificate issued at the end of the conference. Select your sessions and stay in the room to earn the CE total designated for that presentation. Moving in and out of sessions can negatively affect CE tallies. For 2020, the certificates requested after the conference and before January 31, 2021 will cost \$10.00 for ALCA members and \$20.00 for non-members. KEYNOTE SPEAKER

T. Marie King



T. Marie King is an activist, speaker, trainer, and community consultant with nearly 20 years of service, education, and community experience. She travels to cities across the nation serving as an authentic voice for progression. In her hometown, Birmingham, Alabama, she has the opportunity to share her passion about creating pathways to healing, teaching nonviolence, and building a better global community.

In her travels, King has spoken at various seminars, conferences and presented to more than 250 groups and organizations touching youth, college students and adults. She consults with community and national organizations on diversity and inclusion challenges, grassroots efforts, and community healing and conversations. She joined Cortico, a non-profit 501(c)(3) in cooperation with MIT's Laboratory for Social Machines, as Head of Alabama Local Voices Network seeking to foster constructive public conversation in communities and in the media to improve our understanding of one another.

King is a trained facilitator on Truth, Racial Healing and Transformation through the W.K. Kellogg Foundation and a faculty member with the Satyagraha Institute. She holds a B.A. in Urban and Global Economic Development from Beulah Heights University; and M.A. in Leadership and Divinity from Luther Rice University.

In addition to serving the larger community, T. Marie serves on a number of boards and advisory committees in the Birmingham area. She also curates her own community events that involve using the arts to help participants think about how they treat others. She recently published her first book; Six Simple Keys to Living a Lifestyle of Forgiveness.

Dr. Nekeshia Hammond is the host of BWE Mental Health Moment with Dr. Hammond, Amazon international best-selling author, speaker, and psychologist. She is the Founder and CEO of Hammond Psychology & Associates and former President of the Florida Psychological Association and currently serves on the Board of Directors for the Ryan Nece Foundation.

Dr. Nekeshia Hammond is a licensed psychologist and owner of Hammond Psychology & Associates, P.A., a private practice serving children, teens, families, and adults. Her current focus is on completing psychological evaluations (Gifted, learning disorders, ADHD, depression, anxiety, etc.). She was one of 25 psychologists in the country to receive the Early Career Achievement Award from the American Psychological Association, as well as one of 30 individuals selected out of hundreds of applicants to receive an Up and Comers Award from the Tampa Bay Business Journal for the Under 40 years old category.

Dr. Hammond often consults with the media to increase public education about mental health issues, and she has been featured in Life Improvement Radio, CBS Boston, Essence, Tampa Bay Times, Deseret News, Tampa Bay Parenting, AM 1150 WTMP, Ebony, 105.5 WDUV, News 4 San Antonio, and more.

Involved heavily in the community, Dr. Hammond has been active with numerous associations, where she is a key psychologist at the state and federal levels. She advocates for patients' mental health and mental health professionals. She also serves on the Board of Directors for the Ryan Nece Foundation, where the mission is to "be a beacon to teens by empowering them to impact giving in their communities. A Licensed Professional Counselor (LPC) for the State of New Jersey and Approved Clinical Supervisor (ACS), Dr. Branch has more than fifteen years of experience in the mental health and counseling profession. Dr. Branch has worked in community agency and mental health centers, city government, and substance abuse treatment facilities.

Dr. Branch has maintained a clinical private practice since 2010 that focuses on adults, adolescents, couples and families. Dr. Branch currently engages in professional and scholarly work focused on African American male experiences, mentoring, multicultural issues, and increasing the practice of self-care for helping professionals.

ALCA COUNSELOR LOCATOR SERVICE

The Counselor Locator Service is designed to match clients who need services with qualified counselors by location and areas of practice through the use of a simple database search system.

The Alabama Counselor Locator Service is a client-focused service. The service is contained in a database located on the ALCA website. It allows anyone to go into the database and locate the counseling service needed and then to determine the Alabama counselor who can provide this service. The program helps clients find the services needed and helps our counselors identify clients. It has been well received statewide.

The target audience is the prospective client. It is a service designed solely to help the person in need to identify someone reasonably close who is qualified to help with the perceived problem. A byproduct is that LPCs and others have a mechanism from ALCA which helps them identify prospective clients.

Evaluation has been made primarily with feedback from participants. Counselors are steadily requesting to be added to the Service. Feedback comes in the form of comments from these people stating how pleased they are with the service and what a wonderful concept it is. There are several obvious benefits. Probably the greatest is the ability for a client to locate the service needed easily and quickly. From the counselor standpoint it is an opportunity to promote awareness. The professionalism of delivery has also enhanced the counseling image.

Program/Content Session Selection Procedures

Each year comments like these are made: "Why don't we have more content sessions for ______ division?" or "Why do school counselors have so many sessions?" By learning the selection process for session proposals, those who wonder "Why?" will have their questions answered.

20% of the available content session slots are assigned to ALCA. By recognizing that the membership of ALCA share common interests in addition to the specifics of their division memberships, the opportunity exists for developing ALCA membership identity.

80% of the available content session slots are assigned to divisions/affiliates as determined by the following formula: the total number of slots assigned to divisions/affiliates multiplied by the percent of the total ALCA membership for that division/affiliate equals the number of programs selected for that division/affiliate. Any program slots not used by a division are reassigned to the ALCA allotment.

MEMBERSHIP TYPES

Professional Membership is open to all credentialed counselors professionally engaged in counseling, or personnel activities in educational, vocational, religious, rehabilitation, employment agencies, private practice, or other such similar agencies. Minimally hold a Master's degree in counseling.

Regular Membership shall include persons whose interests and activities are consistent with those of the Association, but who are not qualified for Professional Membership (do not hold counseling credentials).

Student Membership is open to any graduate or undergraduate student who is not employed full-time in a counseling-related position and who is actively engaged in a program of study in counseling, guidance, or personnel (Certification by advisor is required).

Retired Membership is open to persons who were members of ALCA at the time of their retirement.

Past President Membership is set for persons who have served as ALCA President; base dues and dues for two divisions are complimentary (final approval required through ALCA office).

Listserv Guidelines

The ALCA listserv is a service for our active ALCA members. All an active ALCA member has to do to join the listserv is contact THE ALCA OFFICE at alca@alabamacounseling.org. You must contact us. You cannot add yourself.

PERFORMANCE DISCLAIMER: The ALCA listserv is intended simply as a service and convenience to our membership. Information is posted on the listserv at the request of members and others who have information that it appears would be of interest to our members. Inclusion on the listserv should not be viewed as an acknowledgement or endorsement of the accuracy of the information being provided. This is simply an information venue. ALCA assumes no liability resulting from the use of this service. Consumers are advised to screen information as they would any other information source. ALCA reserves the right to determine which items will/will not go out on its listserv.

Please note the following hints that should make us all more effective in using the ALCA listserv:

- 1. Remember that ALCA is a monitored listserv. This means that only the listserv manager (Nancy) may place a message on the listserv. By handling messages this way, we filter so that only items which should be of interest to counselors go out to our 3000 listserv enrollees. If you are not interested in a certain message, simply delete it- if you are Chapter X you may not care about Chapter Y news, but there is no need telling us you are not interested in news from other groups-we are going to continue sending the messages for each Chapter/Division/Affiliate. We cannot separate items this finely on the listserv. Messages go to all or none.
- 2. Do remember that it is impossible to monitor and send according to each individual taste and philosophy/moral conviction. We do well, but occasionally something may go out that you think is unnecessary or that you disagree with. Such occasions invoke using the "delete" button for its intended purpose. While we certainly value and read your personal responses, getting one does not mean that we can only operate the listserv based on your individual concepts. We are a diverse and multi-opinioned group. We always try to be conscious of that fact.
- 3. If you hit "reply," the message only comes back to the listserv manager. If you have been "mean", I usually ignore it. Ha! Seriously, if you want to respond to a message, you must respond to the address in the message. DO NOT HIT "REPLY". You are not responding to the message. You are only responding to the listserv manager (Nancy). Having to forward these all the time is frustrating.
- 4. The only way to get a message posted is by sending it to the ALCA office and asking us to post it. We have been empowered to use our best judgment about whether a message is appropriate to send to all counselors; that is, would the message be of interest to a significant cross-section of our members? We try not to distribute advertisements about practices or events that seem to benefit the asker more than the target audience.
- 5. Listserv messages should be sent in "plain text" (part of body of email message) so that all we have to do is forward it. No attachments. Many, many of our member servers routinely block attachments as SPAM or for security reasons. Even if not blocked, they are often too large for system servers to handle.
- 6. We do promote events that are not sponsored by ALCA or its chapter/divisions when they appear to carry a possible benefit or interest to our members. We try to avoid promoting events that conflict with planned ALCA events. For example, we promote almost nothing that might affect

attendance at the Annual Conference either in that timeframe (September, October, November, and December) or the conference general location.

Since fall is the time of year for our annual conference and recognizing that the primary purpose of our conference is training and professional development (including offering professional development hours), it is not very logical to be promoting events for other individuals/entities that could be construed/interpreted as being in competition with our conference during this time frame. In particular this will apply during September/October/November/December timeframe. We will obviously continue to promote our chapter and division events, but even those should try to avoid conflicts near the conference timeframe.

- 7. Effective March 1, 2013, we will no longer publicize office space/real estate as being available to colleagues.
- 8. Effective March 1, 2013, we will no longer as a matter of course, send out individual requests to help locate a particular kind of counselor or one located in a specific area, etc. The ALCA Counselor Locator Service housed on our website was established for this purpose and should be used.

Remember that the ALCA listserv is for our active ALCA members. We are trying to help them with all the info that we send out. We are not trying to reach all those people who do not think enough of what we do to pay their dues. These people eventually get deleted.

This may be more than you ever wanted to know, but reading and trying to adhere to these concepts will certainly make the listserv more effective.
